

#### Documents required for Entry into the United States

- U.S. Citizens Valid Passport
- U. S. Resident Alien Valid Passport and Valid I-551 Document/re-entry permit
- Non-U.S. Citizen Traveling on Visa Waiver Program Valid Machine readable passport/ Approved ESTA application before arriving at check-in for flight to U.S. https://esta.cbp.dhs.gov/

Non-U.S. Citizen - Traveling on Non-immigrant Visa Valid Passport/Valid U.S. Visa, **ESTA not required** 

- Non-U.S. Citizen Traveling with U.S. Immigrant Visa Valid pass-Port, valid U.S. Immigrant Visa and unopened packet from U.S. Embassy
- Canadian/Bermuda Citizens Valid Passport and Valid Non-Immigrant Visa if required

**NEXUS/SENTRY** and **GLOBAL ENTRY** Documents are not valid for entry at Irish Preclearance locations



### **Personal Exemptions**

Returning Resident - Person returning to the live and work in the United States

- Purchases of \$800 or less
- 1 Liter of Alcohol i.e. spirits/wine (if 21 yrs. or older)
- 200 Cigarettes (1 Carton) and 100 Cigars (Cannot be of Cuban origin) All items must accompany traveler

Nonresident - Person visiting the United States All items must accompany traveler and be for their own personal use only

- 1 Liter of Alcohol i.e. spirits/wine (if 21 yrs. or older)
- 200 Cigarettes (1 Carton), 50 Cigars (Cannot be of Cuban origin), 2 Kilos of smoking tobacco (Cannot be of Cuban origin)
- Gifts must be less than \$100 in value (Alcohol cannot be listed as a gift)

Nonresident In-Transit - Person transiting to other destination, final destination cannot be in the United States

> 4 Liters of Alcohol and \$200 or less of tobacco products (Tobacco cannot be of Cuban origin)

### **Agricultural Information**

Declare all agricultural products i.e. meats, all fruits, vegetables anything else that can be consumed or planted. U. S. CBP also needs you to declare if you have visited a farm or ranch anywhere livestock is found i.e. horses, cows, sheep, chickens, any type of poultry.

## **Commercial Merchandise**

Commercial merchandise documented with **A.T.A. Carnet** will be permitted, no other commercial items (samples) will be permitted

#### Money (Negotiable Instruments) i.e. paper money, checks, bearer bonds, traveler's checks

Declare to U. S. CBP if you are carrying/transporting an amount equal to or greater than \$10,000 in any currency type
